1. The Government of Nepal [GoN] *has allocated funds* towards the cost of Jana Narmal School Hostel Building Construction Works, VMRM, Mustang. Contract Identification No: 03/VMRM/NCB/W/077/078 and intends to apply part of the funds to cover eligible payments under the Contract for Jana Narmal School Hostel Building Construction Works, VMRM, Mustang. Contract ID: 03/VMRM/NCB/W/077/078. Bidding is open to all eligible as per Section V of bidding document..
2. **Varagung Muktichhetra Rural Municipality** invites electronic bids from eligible bidders for the construction of **New RCC Building Construction** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 33,000,000.00**
 - Minimum Work experience of similar size and nature: **Successfully completed of minimum one contract within last 10 yrs of minimum value NRs. 20000000.00**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Varagung Muktichhetra Rural Municipality, Mustang or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the payment of a non-refundable fee of **5000.00 NRs** till **17-01-2021 during office hours** in the Project's Rajaswa (revenue) account as specified below .

6. Pre-bid meeting shall be held at Varagung Muktichhetra Rural Municipality, Mustang at 08-01-2021 12:00 hrs.
7. Electronic bids must be submitted to the office **Varagung Muktichhetra Rural Municipality** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00** on **17-01-2021**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **17-01-2021 13:00 hrs** at the office of **Varagung Muktichhetra Rural Municipality, Mustang**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 750000.00, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
