Sealed or electronic bids must be submitted to the office Varagung Muktichhetra Rural Municipality, Office of the Rural Municipal Executive, Kagbeni by hand or through PPMO website **www.bolpatra.gov.np/egp** on or 12:00 hrs on 2076/12/30(April 12th, 2020). Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs. And 2076/12/30 (April 12th 2020) at the office of Varagung Muktichhetra Rural Municipality, Office of the Rural Municipal Executive, Kagbeni. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, mentioned above bid Security Separately, which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
